Approving Accounts, Accounting System Changes, Document Changes, Bonding and Health Insurance Changes Associated with the Retirement of Fiscal Officer Elizabeth A. Broisus and the Appointment of Gregory L. Sullivan

Whereas, the Fiscal Officer Elizabeth A. Brosius reported to the Board tending her resignation as Fiscal Officer of Hanover Township effective at the end of the day August 31, 2015; and

Whereas, according to the Ohio Revised Code, the Board of Trustees appointed a qualified candidate Gregory L. Sullivan as authorized through Resolution No.42-15 approved August 12, 2015 to fill the unexpired portion of the Fiscal Officer's term which runs through March 31, 2016; and

Whereas, for purposes of a smooth transition and to maintain efficient operations it is necessary to authorize a number of changes related to accounting systems, bank accounts, official documents and authorize insurance coverages,

Section I. That Gregory L. Sullivan in his capacity as Fiscal Officer is hereby designated the official contact and signatory for Hanover Township banking accounts through First Financial.

Authorizing the Filing of August 2015 Applications for the Butler Rural Community Connections Grant Program

Whereas, the Board of Trustees has reviewed the requirements for the August 2015 Community Connections Grant program sponsored by the Butler Rural Electric Cooperative; and,

Whereas, the Township has a Hanover Township Memorial Park Master Plan for continuing the development of the Hanover Township Memorial Park and identified Strategic Planning Objectives including but not limited to use of the Community Center, Road Department and Fire Department; and,

Whereas, reduction in revenues resulting from property devaluations and continued funding cuts from the state have reduced the ability of the Township to fund a number of projects and equipment such as those referenced herein; and,

Whereas, the Board of Trustees rates basic services such as those items that relate to serving the emergency needs of the public as a high priority and recognize the need for the continued development of the Hanover Township Memorial Park, Community Center, Safety Services, Road Maintenance operations and programming that serves the overall best interests of Township residents; and,

Whereas, the projects submitted for Community Connections Funding have no assigned funding source but the Township will continue to focus on key priorities in the aforementioned areas,

Section I. That Board authorizes up to two applications to be submitted at the Administrator's discretion to the Rural Cooperative Community Connections Program by the end August 2015 as reflected in the attachment lal Attachment to Resolution No. 46-15 Grant Projects.

Section II. That the Township Administrator is hereby authorized to complete the necessary documents and sign the appropriate forms to submit one or both applications referenced herein.

Whereas, the Fiscal Officer reported on recent revenue adjustments as the result of revenue derived from a memorial donation of \$480.00; and

Whereas, the Fiscal Officers recommends acknowledgement of the foregoing and amending the Revenue and Appropriation documents as well as establish the necessary accounting structure to accurately reflect the acceptance and expenditure of these additional funds totaling \$480.00; and

Whereas, the Board of Trustees concurs with the recommendation of the Fiscal Officer.

Section I. That to promote sound and efficient fiscal operations for the Township, the Certificate of Estimate Resources and Permanent Appropriations for Fiscal Year 2015 are hereby amended subject to the County Budget Commission approval reflecting the receipt of additional revenue for General Fund 1000 of \$480.00 and appropriating said amount to fund to the General fund for use as a memorial project in the park.

Section II. That the Fiscal Officer is authorized to take all necessary steps to implement said 2015 Revenue a Expenditure adjustments for the Permanent Appropriations and make payments accordingly.
